1. **SWEEPSTAKES DESCRIPTION AND ENTRY DATE:** The Roadhouse Romance Sweepstakes (the "**Sweepstakes**") entry period begins on Thursday, February 8, 2018 at 5:00 p.m. Central Time ("**CT**") and ends on Wednesday, February 14, 2018 at 11:59:59 p.m. CT (the "**Sweepstakes Period**"). Entry must also comply with all Official Rules. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes.
